Information We Collect

- Device and Usage Information
 - Device Data: Information such as IP address, device type, browser type, operating system, and app usage data may be collected automatically when you use our Progressive Web App.
 - Cookies and Tracking Technologies: We use cookies and similar technologies to improve user experience, analyse usage, and personalise content.

How We Use Your Information

We may use your information to:

- Provide, personalise, and improve our services.
- Calculate your biological age based on health data provided by you.
- Generate lifestyle recommendations and insights based on your biological age score
- Communicate with you about your account, updates, or support inquiries.
- Conduct internal research, testing, and analysis to improve our services.
- Comply with legal obligations and protect our rights.

Disclosure of Your Information

We may share your information only in limited circumstances:

- Service Providers: We engage trusted third-party vendors for technical support, data storage, and processing. These providers have access to your information solely for performing their functions and are contractually obligated to protect it.
- Legal Compliance: We may disclose information if required by law or in response to valid legal requests from public authorities (e.g., court orders, government agencies).
- Business Transfers: If our business is acquired or merged, your data may be transferred to the new owner under similar privacy standards.

We will not sell, rent, or lease your personal information to third parties for marketing purposes without your consent.

Your Privacy Rights
